Re: A CALL TO ACTION!

To our fellow Federal Bar Association members, our fellow federal practitioners and all practicing Puerto Rico attorneys:

First and foremost, I hope you and your family and friends are in good health and in the path to recovery after the recent hurricanes. Today, more than a month after hurricane Maria struck Puerto Rico's shores, the island is still slowly (but surely!) getting back on its feet. We are all aware of the current statistics regarding the amount of families and businesses without power and running water and know first-hand the daily struggles that many of our own families, friends and colleagues are going through. As attorneys, many of us have asked ourselves what can we do to help others during this time of need.

The Federal Bar Association, Hon. Raymond L. Acosta Puerto Rico Chapter ("FBA") is working with other organizations not only to develop initiatives to assist those less fortunate in these pivotal times in Puerto Rico, but to identify volunteering opportunities for those willing to give what, for attorneys, is arguably our number one asset: our time and experience.

## FEMA<sup>1</sup> Disaster Assistance Drive

One of the areas where short-term assistance is desperately needed is helping people around the island in the completion of FEMA assistance applications. As you all know, there are currently thousands of people across Puerto Rico that are not able to receive aid from FEMA or other agencies due to lack of access to a working phone or an internet connection. The FBA is working with other public and private entities and organizations to recruit attorneys willing to donate their time to spend a few hours at designated judicial centers around the island and other locations where remote internet access has been set up for this task. All that is required is a few hours of your time, a personal computer or tablet device and willingness to help.

There are two phases to this project. The first involves the training of those of you who volunteer. The second, the actual execution of the service. Thanks to

the assistance and resources of the Legal Services Corporation of Puerto Rico and the public interest initiative "Ayuda Legal Huracán María," the FBA is offering its membership and any interested attorneys several free training sessions on how to volunteer and help in the completion of FEMA assistance applications. In addition, in the coming days we will distribute a schedule with the dates and locations around the island where those that have participated in training sessions can report to assist those less fortunate in completing said applications.
